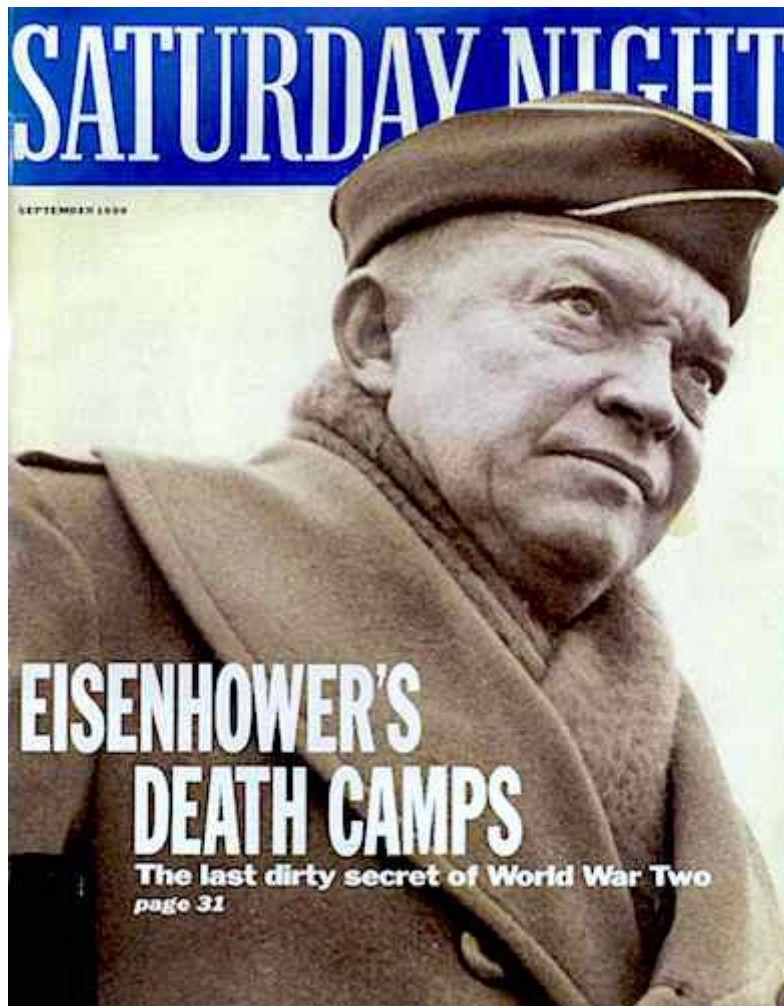

Eisenhower's Rhineland Meadow Extermination Camps



"God I hate the Germans," Eisenhower wrote to his wife in September of 1944.

All all of the unconscionable crimes of WWII committed against the Germans, one of the worst crimes was that caused by the American occupiers. After Berlin fell to the Germans, the defeated soldiers were round up, and detained in large swathes of land cordoned off with barbed wire. These open-air prisons were run by the U.S. military with General Dwight D. Eisenhower overseeing their operations. These open-air prisons were just that, open to the extreme environments, with no toilets, or other sanitary conditions to prevent the rampant spread of disease. No food was provided whatsoever, as Red Cross rations, which were provided to the detainees was denied to all.

From 1945-1953 Germans suffered the real holocaust of the war. Millions were displaced through allied bombings, while millions more were thrown out of their homes. It has been estimated that 9-15 million Germans died during that time, as a result of the Zionist Morgenthau Plan. Part of that plan was for Eisenhower to operate death camps. The extermination “camps” were modeled after the concentration camp the British imperialists held women and children who starved to death by the thousands as their men fought to retain control of the region in South Africa where they had discovered gold, and diamond mines.

Eisenhower's Death Camps are yet another example of untaught, and therefore unknown extermination of the Germans at the end of WWII. The conditions the German men, women, and even children were detained under was a deliberate policy of extermination that was committed against the surrendered German forces by the Allies, in post-war Germany (Rheinwiesenlager).

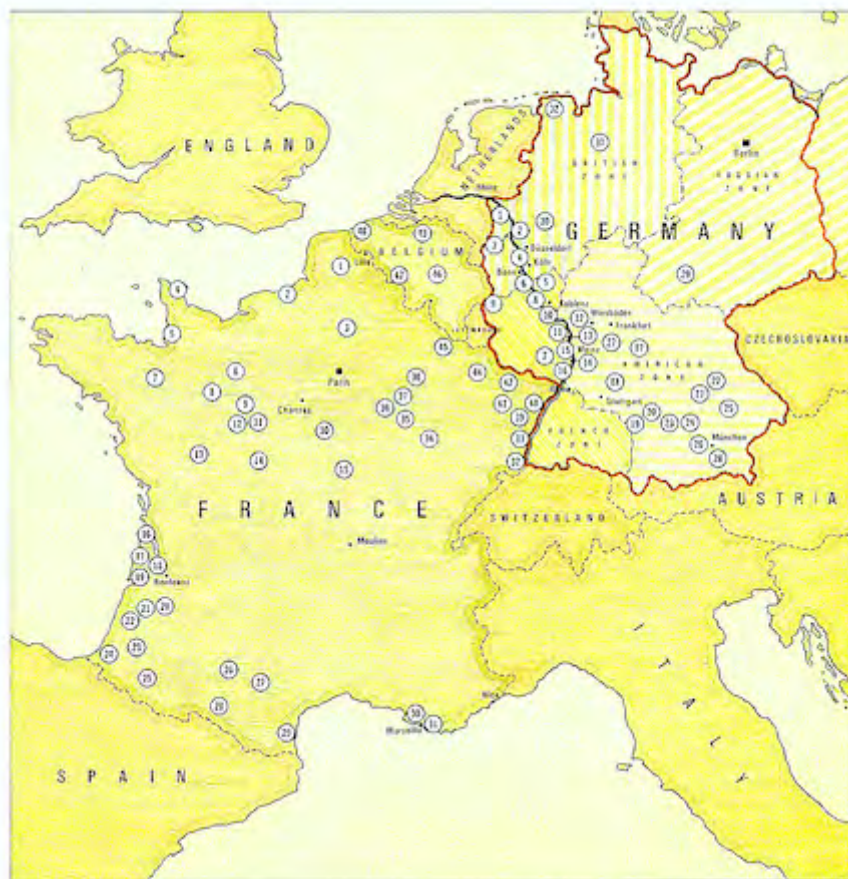
Expulsion of Ethnic Germans for extensive details about the genocide aimed at the Germans by the Jews throughout Eastern Europe for decades prior to the outbreak of WWII. Patton was ordered to inflict as much suffering on the German captives as possible, which he refused. Patton wrote extensively from first-hand knowledge how Eisenhower was using war crime tactics to obtain false confessions, torture, rape, and murder against former Germans soldiers.

The Rhineland genocide is not the only crimes that Eisenhower has been accused of. Eisenhower, as president of the U.S. would plan the murder of the Prime Minister of Congo, Patrice Lumumba. Declassified CIA documents show that the Congolese leaders who killed Lumumba received money and weapons directly from the CIA. In 2000 a declassified interview with Robert Johnson, who was the minute keeper of the U.S. National Security Council at the time, revealed that then president Eisenhower told CIA chief Allen Dulles that "Lumumba should be eliminated." The interview from the Senate Intelligence Committee's inquiry on covert action was released in August 2000. In December 2013, the U.S. State Department admitted that President Eisenhower authorized the murder of Lumumba. CIA Chief Allan Dulles allocated \$100,000 USD to accomplish the act. Lumumba was only a Prime Minister of the Congo for 80 days.

Eisenhower's Rhine Meadow camps were part of the Morgenthau Plan to murder as many Germans as possible, to strip them of their homes, land, businesses, farms, factories, and infrastructure so as to to ensure the German people were wiped from the face of the earth.

Another book that Zionist publishers refused to publish is James Bacque's, *Other Losses*. This revealing book shreds the notion of a higher moral authority most Americans take for granted as their legacy of victory in WWII. Bacque carefully researched reams of Army records and exposes the cover-ups, obfuscations, and downright distortions perpetrated by Army high command in the years that followed the allied victory of Germany. Bacque details General Eisenhower's pathological hatred of Germany, the German people and his systematic starvation and neglect of disarmed German soldiers as well as civilians. The death count is staggering, and the behavior of those in command, is nothing short of the most egregious crimes against humanity. The foreword of Bacque's book was written by Dr. Ernest F. Fisher, Jr., a retired colonel, and senior historian for the U.S. Army.

Academia and the media, which is nearly entirely controlled by Zionist, and their agenda, have never launched any investigations into the accuracy of Bacque's work. One of Zionism's tactics is to not engage dialogue, or address anything the controverts their narrative. Not permitting material to be published is a much greater deterrent to the information therein than burning volumes publicly. The fact is, *Other Losses* is a carefully researched book which marshals the facts, and reaches its conclusions by an inexorable process of elimination. Nothing Bacque has written has ever been scrutinized for its veracity.

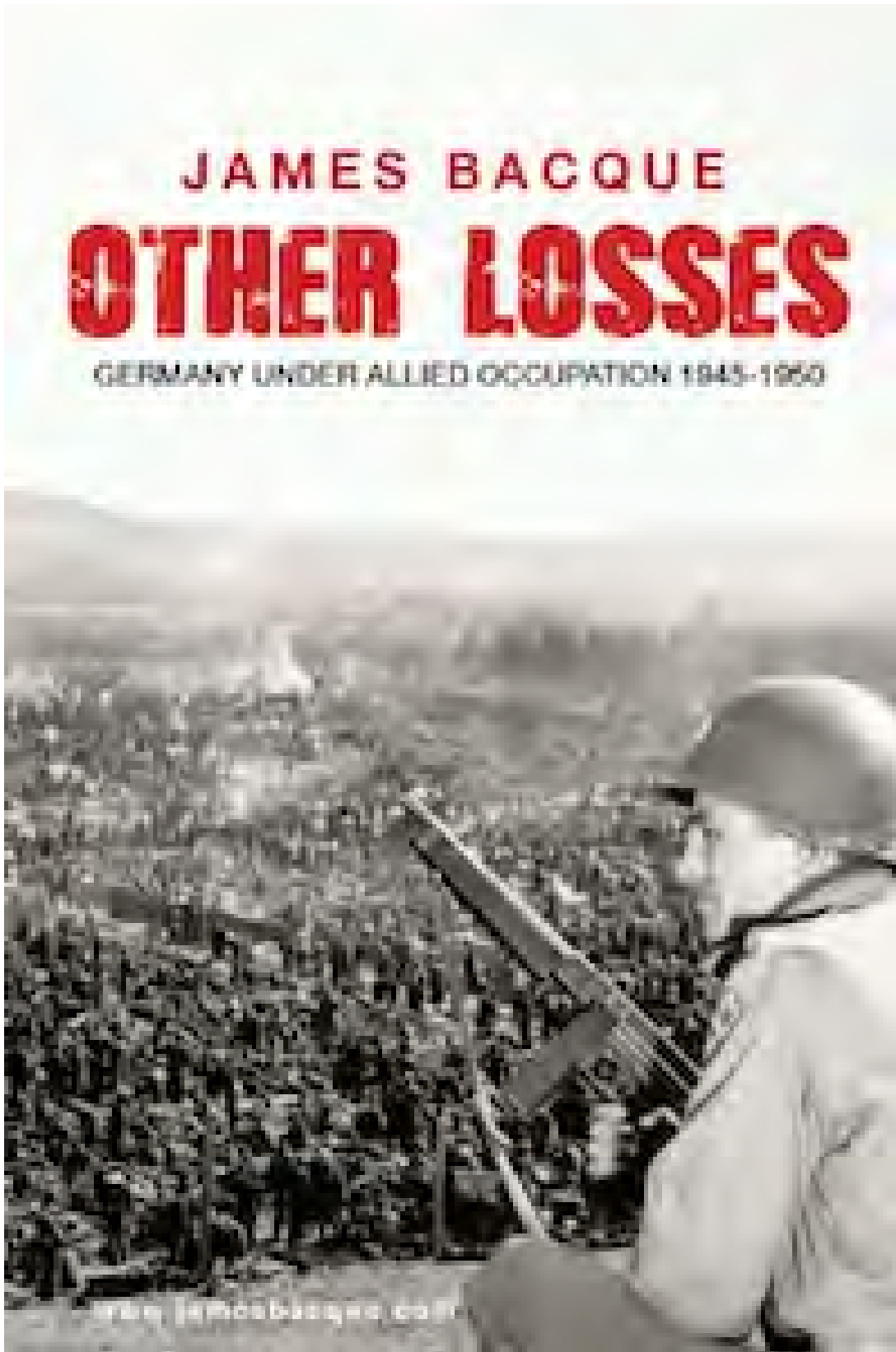

Bacque's book also examines the abusive, and sadistic treatment of POWs, and the employment of slave labor by the western Allies. Bacque's second book, *Crimes and Mercies* goes into greater details regarding the massacre of German civilians in Eastern Europe, and what he believes was a process of deliberate starvation of German civilians for several years after the war. Bacque concluded that 1.1M POWs were executed by Eisenhower, 2M were forced into slave labor employed in the west with 900K forced into slavery by the French, mostly POWs but also civilians, 300K of which died from starvation and abuse. Another 2.1-6 M civilians were massacred in the East, and the deaths of another 5.7M civilians occurred from 1945 to 1950. In *Crimes and Mercies*, one account of a survivor is Siegfried, who was captured at the end of the war. The day the war ended the treatment of the POWs went from proper to brutal. Siegfried was sent to France as a forced slave, and only survived because the major commanding his last camp told the men that he had been a POW for 5 years and had been treated correctly, and what was being done to them was a terrible crime, and that he would do everything to see that they survived. A family friend of Siegfried, formerly a Ford (US) executive and at the time executive of VW, was kidnapped out of his office, and sent to France as a slave. This man's family had no idea what happened to him. He had merely disappeared, as millions of Germans had. When Bacque's second book became published, Zionists took notice and began trolling online conversations attempting a smear campaign against Bacque. Regardless, as Bacque revealed that soon as the Second World War ended in 1945, Canada and the United States began shipping food to the hundreds of millions of people who were

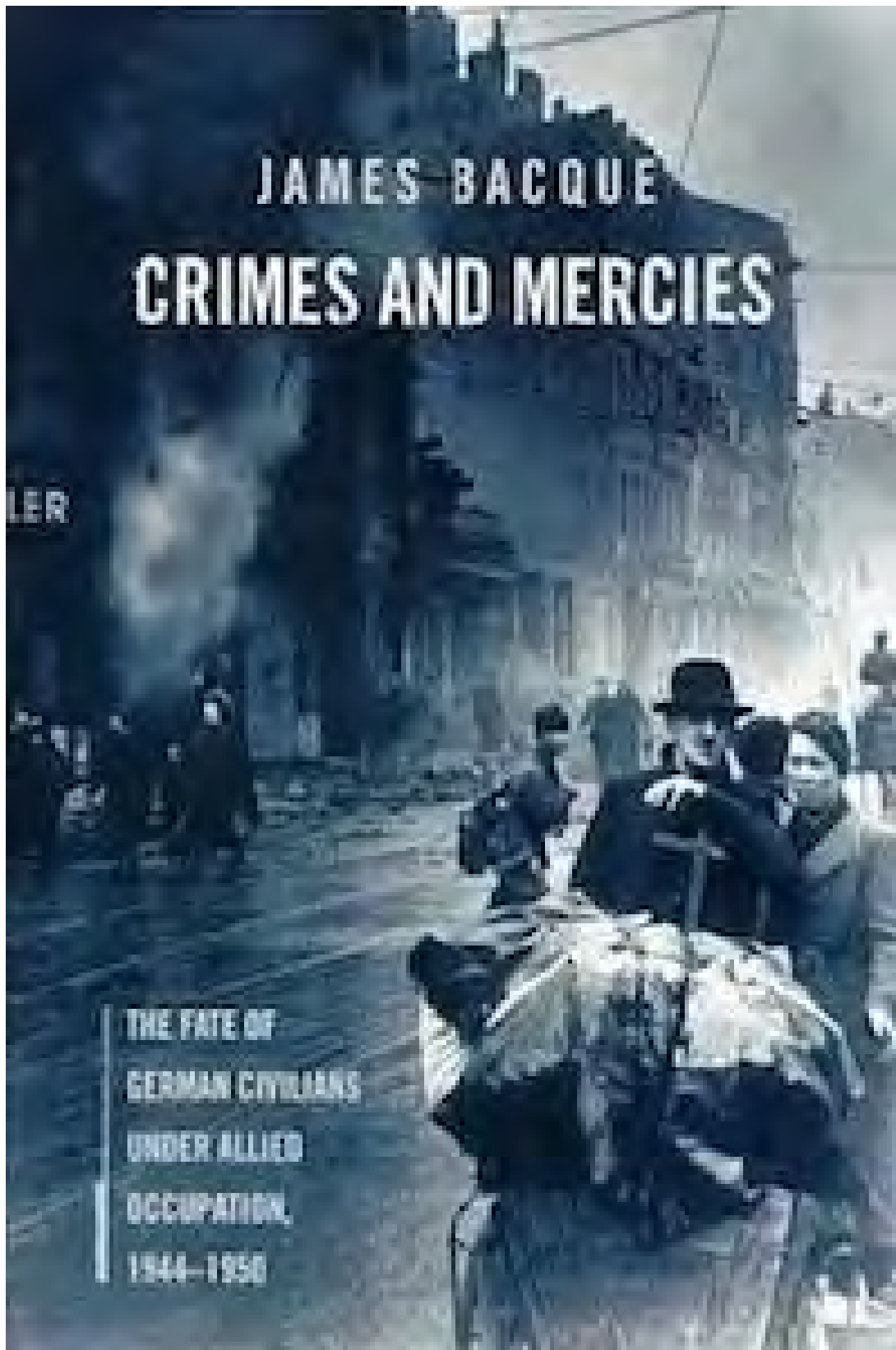
facing starvation. These humanitarian supplies fulfilled the highest ideals for which the Americans had fought since the Revolutionary War. American generosity seemed to have no limit. They fed their former enemies in Italy and Japan, only the Germans were intentionally starved to death.

It is well-known that the Allies hung German official for alleged war crimes, including “gassing” Jews, and committing the Katyn Massacre. Today, with the aid of Almanacs, publications available online that the Zionists never intended to see the light of day, FOIA records, scholarly and others sources, including Auschwitz changing its death total from 1990’s 4 million, to 1995 1.5 million, the the Zionists “six million” figure fails the records. Simply the Jews fabricated German “crimes” so as to obtain a “homeland” in Israel. Regardless of Zionist end goal, millions, upon millions of people suffered throughout the world. Germany is still paying reparations for crimes the nation had not committed. The “holocaust” industry reaps billions, imposing on school children around the world as part of compulsory education, the Zionist false narrative. Zionists have also had laws passed to make it a crime to question this false narrative. In many places, even in the U.S. new legislation is being passed, and rightfully challenged in courts, making it a crime to participate in boycotting Israel. When a foreign entity has that much influence over the rights of a nation’s citizens, that foreign influence is overreaching, and must not be permitted to continue in such a manner.

What is not generally known is that after WWII the occupying Allied armies carved off 25% of Germany’s most fertile land, and placed it under Russian and Polish control. This resulted in the forced expulsion of approximately 16 million ethnic Germans from homelands they occupied for upwards of a thousand years. This same carving up of German after WWI, is exactly what brought about the conditions that resulted in WWII, namely the French occupying the Rhineland Meadows, and the Poles ethnic cleansing of Danzig, and the Sudetenland. Millions upon millions of Germans were forced out of their homes, and those that survived death marches were round up in Berlin, a city that was utterly destroyed. Starvation, and exploitation of women and children began immediately. Germans were not permitted to emigrate to their country of origin, and millions of prisoners were forced into slave labor camps. International charitable aid to Germany was banned for several years, and greatly impeded when aid was finally permitted. When aid did finally arrive, it was far too late for millions of people. This was all part of the Morgenthau Plan to wipe Germans off the face of the earth. U.S. secretary of the treasury Henry C. Morgenthau Jr., a Zionist Jew, slashed production of oil, tractors, steel and other products that had been essential to the war effort. The U.S. cut fertilizer production by 82% to prevent planting crops to sustain life. German goods were undervalued, which the Zionist controlled. German were deprived of cash, which was needed to buy food. Germany’s industrial production fell by 75% as much of the nation’s factories had been taken apart and relocated to the Soviet Union, Poland and France.

The loss of so much fertile land and the drop in fertilizer supplies caused agricultural production to fall by 65%. Sixty million people starved in their open air prison, as they were also denied housing. The mass expulsion from one part of Germany to another, approved at the Allied victory conference in Potsdam in July and August, 1945, were enforced "with the very maximum of brutality," wrote British writer and philanthropist Victor Gollancz. Canadian writer and TV producer Robert Allen, in an article titled "Letter From Berlin", in Reading magazine (February, 1946), described the scene in a Berlin

railway station as refugees arrived in late 1945, *“They were all exhausted and starved and miserable. A child only half alive. A woman in the most terrible picture of despair I’ve seen. Even when you see it, it’s impossible to believe. God, it was terrible.”* What the Jews claim to have suffered at the hands of Germany, even if any of it was true, pales in comparison to the methodical plan carried out by the Zionists. 

In the West, the plan to dismantle German industrial capacity began at the British headquarters of General Dwight Eisenhower in August, 1944. Meeting with Morgenthau, Eisenhower prescribed a treatment for Germany that would be *“good and hard,”* giving as his reason that *“the whole German population is a synthetic paranoid.”* Morgenthau took a written version of their discussion to U.S. president Franklin Roosevelt and British prime minister Winston Churchill when the two met in Quebec City in September, 1944. British foreign secretary Anthony Eden, U.S. secretary of Cordell Hull and the U.S. secretary for war Henry L. Stimson all protested vigorously against the Morgenthau Plan because a pastoralized Germany could not feed itself. Mr. Hull and Mr. Stimson told Roosevelt that about 20 million Germans would die if the plan were implemented. Morgenthau noted that this was the plan, the entire destruction of the German race, forever. In the New York Post for Nov. 24, 1947, Morgenthau wrote, *“The Morgenthau Plan for Germany became part of the Potsdam Agreement, a solemn declaration of policy and undertaking for action signed by the United States of America, Great Britain and the Union of Soviet Socialist Republics.”*

For more than 45 years, historians have never disputed a massive survey conducted over four years by the government of chancellor Konrad Adenauer, which stated that some 1.4 million German prisoners had died in captivity under Eisenhower’s command. What is still disputed by the two sides is how many died in each side’s camps. Each has blamed the other for nearly all the deaths. The fall of the Soviet empire in 1989 provided a spectacular test of the truth, If the KGB archives recorded how many Germans died in Soviet camps, the world would know how many died in the West. Further, all *“genocidal gas chambers”* were only reported discovered by the Soviets. The Soviets did finally admit to the slaughter of 22-27,000 Jew officers in Poland, which were part of German officer war crimes trials that took place in Nuremberg. Will the Russians, who are under constant assault by Jewish owned western media someday tire of it, and admit to what experts, revisionists, scholars, and historians already know, which is the vast majority of what Germany is accused of, including using Zyklon B to gas *“six million”* Jews was, and continues to be, a fraud, perpetrated at the time against Germany, for initiating war with the USSR when Germany, and the Soviets had a peace treaty?

One KGB report prepared by a Colonel I. Bulanov shows that 450,600 Germans died in Soviet camps. Given the figure of 1.4 million deaths, this meant that close to one million had to have died in camps run by the Americans. In addition, the KGB records show that the Soviets had imprisoned hundreds of thousands of civilians, of whom many thousands died. This has always been the greater tragedy, which was the fate of German civilians, many dying in torture camps, including one run by Shlomo Morel, a former prison camp warden who fled Poland to Israel to escape a war crimes trial.

The recent declassification of the Robert Murphy Papers at the Hoover Institute in Stanford, California, and the Robert Patterson manuscript papers in Washington focused the picture. Mr. Murphy had been chief U.S. diplomatic adviser in Germany, and Mr. Patterson the secretary for war after 1945. Some of Murphy’s papers show a catastrophic death rate in Germany, highlighted by a surprising comment by Murphy in discussing German demographics. Murphy wrote in a State Department paper in 1947 that the U.S. statistical projection of births, immigration and officially reported deaths showed that over the next three years the German population should be 71 million, but that *“to be conservative and in view of the*

present high death rate in Germany, a figure of 69 million will be used.” In other words, Mr. Murphy was basing high-level U.S. policy on the knowledge that the actual German death rate was approximately double the rate officially reported to Washington by the U.S. military governor.

In the National Archives in Ottawa, documents seized by Canadians in 1946, show a death rate in the city of Brilon in north-central Germany tripled the total reported by the Allies for their zones of Germany in 1945-46. The U.S. Army medical officer in Germany secretly reported that the actual death rate in the U.S. zone in May, 1946, was 21.4 per 1,000 per year, or 83% higher than the military governor was reporting to Washington. The documents in Ottawa, Moscow, Washington and Stanford reveal that the Allies not only destroyed most major German industry, they also reduced German food production to the point that Germans received far less food to sustain life for several years. *“From 1945 to the middle of 1948, one saw the probable collapse, disintegration and destruction of a whole nation,”* written in a judgment of a U.S. Navy medical officer who was located in Germany. Behnke compared German rations set by the occupying Allies at 400 calories per day was really around 1,000 calories each day. Officially for more than two years, the caloric consumption was never more than 1,550. Under German occupation, the Dutch received 1,394 calories each day. For his part in “starving” the Dutch, NSDAP commander Arthur Seyss-Inquart was hanged by the Allies.

A comparison of the German censuses of 1946 and 1950 show the effect of the food shortages. The 1950 census showed 5.7 million people fewer than there should have been according to the number of recorded in the 1946 census, minus officially reported deaths, plus births and immigrants expelled from the east and returning prisoners, in the period from 1946 to 1950. Murphy had, indeed, been conservative, partly because he underestimated the number of prisoners due to return to Germany from Russia. The total tally of unacknowledged deaths among the prisoners, refugees and non-expelled civilians comes to around nine million people between 1945 and 1950, far more than the number who died during the war itself. All of these deaths were surplus to those actually reported.

While Germans starved, the Canadian-U.S. relief program swung into action in other parts of the world. Former U.S. president Herbert Hoover, then chief food adviser to president Harry Truman, flew around the world assessing need and supply. He found big regions of food poverty, as there has always been and still are, but not insurmountable world food shortage. In fact, world food production in 1945, according to the U.S. government statistics, was 90% of the average of the years from 1936 to 1938. By the end of 1946, it was virtually normal. Hoover begged, borrowed and bought enough food from the few other surplus countries, such as Australia and Argentina, to feed nearly all the world's starving. He congratulated Canadians warmly for their co-operation in a CBC speech in Ottawa in 1946, *“To Canada flows the gratitude of hundreds of millions of human beings who have been saved from starvation through the efforts of this great Commonwealth.”* Hoover knowingly permitted the Germans to starve. Kenneth Wherry and William Langer, protested against *“this addlebrained brutal and vicious Morgenthau Plan.”* Truman asked Hoover to intervene. Hoover spoke to North Americans via broadcast stating, *“Millions of mothers are today watching their children wilt before their eyes.”* Infant mortality rates in some German cities were 20% per year, catastrophically higher than the average in Germany before the war or in any contemporary European city. Cases of tuberculosis among children in Kiel, in the British zone, increased by 70% over the prewar period. Hoover finally called for mercy to Germany. *“I can only appeal to your pity and your mercy. Will you not take to your table an invisible guest?”* Canadians and Americans did set the table for the invisible guest. According to prime minister Mackenzie King's chief foreign-affairs adviser, Norman Robertson, Canada was the only country that had kept its food commitments to help the starving Germans. Only in Canada did rationing and price controls continue long after the war so that others could be fed. Some surviving Germans treasure the memory of the “Hoover Speise” (meal) that warmed

their bodies at school in 1947. Many millions, including hundreds of thousands of Canadians born in Germany, remember their homes in the parts of Germany annexed under Polish or Russian rule. None dreamt of reparations, they only yearned to know the plight of the Germans.
